\*Physical description of testing area: The testing area consists of 24 computers with two computers located at each testing table. Candidates can be separated by spacing them at different tables or by the use of testing dividers. This will be determined by the number of test candidates at each session. The room has an administrator's desk in the front of the room which allows a view of each test station. The administrator will also do walk throughs during the test in order to monitor the test candidates.
