

Any person substantially affected by the proposed policy(s) who wishes to challenge the validity must file a petition with the board's secretary (12 copies) in conformity with section 120.56, 2007 Florida Statutes, not later than 10 days prior to the meeting of the board, as set forth above. The hearing is open to the public.
