Mr. Lynn,

During our Technology Upgrade Project meeting, Vickie and I presented a 2 year plan to Mr. Emerson and Mr. Harrell. As part of this plan we asked for labor to assist our District Technical Support staff during the summer to help upgrade/replace existing XP computers. We would like to hire up to (10) Teacher Assistants for Technology and have them work up to (20) days during July and August. Our understanding was if they were doing a job similar to their normal duties, we are required to pay them their regular hourly rate. We have had several Tech Contacts express interest to work during the summer, but do not know if they can work all 20 days. Mr. Harrell provided funding for 1111 replacement computers to be order before the budget ended and they are scheduled to start arriving the second week of July. Our plan is to use these TA's to assist setting up these new computers at the Middle Schools before school begins. We estimated the cost to be around **\$42,000.00** based on \$25 per hour X 10 Tech Contacts X 20 Days. I think we will be lucky to get 5-10 day commitments for worker this late in the summer. Please let me know how to proceed if approval is given.
