The Santa Rosa County School District is the grantee for the Santa Rosa County District Schools Head Start and Early Head Start Program. It is the goal of this grantee to remain in compliance with the Head Start Performance Standards and other federal requirements at all times, thus providing students and their families with a quality preschool program emphasizing school readiness, academic achievement, and social and emotional stability.

Head Start Performance Standard 1310.15(c) lists specific federal guidance for the operation of vehicles.

Effective June 21, 2004, there is at least one bus monitor on board at all times, with additional bus monitors provided as necessary, such as when needed to accommodate the needs of children with disabilities. As provided in 45 CFR 1310.2(a), this paragraph does not apply to transportation services to children served under the home-based option for Head Start and Early Head Start.

In alignment with Head Start Performance Standard 1310.15(c), the Santa Rosa County School District, grantee for the Santa Rosa County District Schools Head Start and Early Head Start Program would like to request a waiver for the budget period of March 1, 2014 - February 28, 2015, for the bus monitor requirement as mandated by Head Start Performance Standard 1310.15(c) for the following reasons:

- The Santa Rosa County District Schools Head Start and Early Head Start Programs have a collaborative agreement with the Santa Rosa County District School's contracted transportation provider, Durham. This collaborative agreement provides bus transportation as in-kind to the Head Start Program for an estimated 18% (approximately 45 students) of the total Head Start student population to and from school each school day.
 - Any Head Start enrolled student who lives outside of a two-mile radius, but within a specified school zone in which a Head Start Program site is located, is eligible for District-contracted bus transportation.
 - The Head Start and Early Head Start Programs located at the Santa Rosa District School's Pre-K Administrative site, T. R. Jackson Pre-K School, rely solely on parent-provided student transportation to and from school each day. It should be noted that with this arrangement, the average monthly attendance for the Head Start and Early Head Start Programs have been at or above the mandated 85% during the previous school year.
- Of the contracted buses providing transportation to the Head Start Program, there are no more than 3 Head Start students on a bus at all times. The population of Head Start students transported via bus transportation to and from school each day represents an estimated 18% of the total population of Head Start students.

- Of the 45 Head Start students transported by the District's contracted transportation services, it
 would be considered a disruption in the program's daily operations to provide bus monitors for
 such a small percentage of students who are transported to and from school each day via contracted
 bus service provided as in-kind to the program.
- The in-kind support given by the Santa Rosa County District Schools through the transportation contracted services helps the Head Start Program to meet the grant matching requirements of the Head Start Performance Standard 1301.20.

We greatly appreciate the opportunities that this grantee has been given to serve the Head Start and Early Head Start eligible children within our community. Award of this transportation waiver will allow us to continue to provide quality and efficient integrated services to all eligible participants.
