Education and Assessment:

- The Classroom Assessment Scoring System (CLASS) Observations took place this month. CLASS is a researchbased observation that focuses on emotional support, classroom organization, and instructional support. The CLASS Observation tool is an integral part of the Triennial Audit Reviews.

- One (1) student was dual enrolled into an ESE classroom to help with a language delay that was diagnosed through testing this school year.
- Two (2) IEPs were developed for students with speech delays that have been diagnosed through testing this school year.
- Ms. Gail Patterson, the Licensed Mental Health Consultant for SRCSB Head Start program sat in with the Multi-Tiered Support System (MTSS) team to help develop a plan for a student that bites.

Parent, Family, & Community Engagement
