Dear Mr. Wyrosdick,

School lunch program regulations, according to 7 CFR 210.14(e), require school food authorities (SFAs) participating in the National School Lunch Program to charge full paid students the difference between free meal reimbursement (\$3.00) and paid meal reimbursement (\$0.30) for lunch. That difference is currently \$2.70 (\$3.00 - \$0.30 = \$2.70). Districts are allowed to raise rates gradually. In order to be in compliance with the current legislation, prices for the upcoming school year are required to be set to give a weighted average of \$2.45, with meal counts in consideration. The Florida Department of Agriculture and Consumer Services has agreed to allow price increases for SY 15-16 to give a weighted average of \$2.44, provided that the district will continue to work towards the goal of a weighted average of \$2.70 for paid meals.

It is recommended that this price increase be implemented by 10 cents at the elementary level, and 5 cents at the secondary level next school year, with a 10 cent increase both of the following years. During SY 18-19, it is recommended that prices increase by 5 cents at the elementary level, and 10 cents at the secondary level.
