## **Professional Standards**

•Professional Standards for school nutrition professionals is a key provision of the Healthy, Hunger-Free Kids Act of 2010 (HHFKA).

•The rule, requires a minimum amount of annual training hours for all state directors of school nutrition programs, school nutrition program directors, managers, and staff.

 Required training topic areas will vary according to position and job requirements.

• There are also minimum hiring standards for new state directors of school nutrition programs, and school nutrition program directors.


•Final rule will take effect on July 1, 2015
