

MEETING MINUTES
SCHOOL BOARD OF SANTA ROSA COUNTY
June 11, 2015-6:30 PM

A. Call to Order and Roll Call

The School Board of Santa Rosa County met in regular session at 6:30 p.m. with the following members present: Mr. Hugh Winkles, Chairman, Mrs. Carol Boston, Mrs. Jennifer Granse, and Mr. Scott Peden. Dr. Diane Scott informed the Board at the May 21 Board meeting that she would be out of town on June 11 and would be unable to attend. (Dr. Scott is traveling to Harvard University on behalf of the University of West Florida.) Also present was Timothy S. Wyrosdick, Superintendent of Schools and Secretary and Paul R. Green, Board Attorney.

6. Custodial Quarterly Report 061115

Steve Sport with Southern Management came forward to present the Custodial Services quarterly update. Mr. Sport began by sharing Quality Control scores: Pre-K and elementary averaged 3.25; intermediate, middle and high are also 3.25. On June 4 he brought all custodians together for annual POD training which includes carpet care, how to strip and re-wax tile floors, bathroom/classroom cleaning, safety (including slips, trips and falls), proper lifting, etc.

Mr. Sport reviewed a presentation that Debbie Price with the Santa Rosa County Health Department recently made to the custodial employees on diabetes, insect bites, epipen procedures, and how to quit smoking.

Mr. Sport shared that Larry Dixon at Gulf Breeze Elementary was the first "home stand hero" and was recognized at a recent Blue Wahoos game. Larry has been an employee with Southern Management for approximately ten years; has served as president of the Gulf Breeze Youth Sports Association for twelve years; and is an Air Force veteran.

Southern Management is "rebranding" to "ABM" (name change).

Last, he recognized Southern's Employee of the Quarter, Ms. Windy Holley, from Dixon Primary.

7. Growth Management

Assistant Superintendent Joey Harrell came forward to provide information regarding the request for Board approval for the cost allocation of Phase 2 (in the amount of \$25,000) for the School Planning and Concurrency Management -*

Program for Resource Efficient Communities, University of Florida (Growth Management).

Superintendent Wyrosdick noted that one page of the handout changed and provided a copy for Board members of the corrected page 5.

This is Phase 2 of the partnership the Board approved in February with the University of Florida for the development of a School Facilities Planning "Geodatabase" and assistance in the application of the "Geodatabase" to school planning decisions. This is data driven and will enable the District to have facilities ready when students arrive to adequately house them. Phase II will culminate in a Board workshop at which Gene Boles, Senior Fellow and Project Coordinator for the Center for Better Communities, will present their findings and recommendations.

Board Member Carol Boston noted that the information presented refers to communicating with local government officials in cities but Pace and Navarre are not incorporated. Mr. Harrell confirmed that there would be communication with those community leaders also. This is the data collection phase to see where needs are, transfer into usable form, and tailor it for Santa Rosa.

1. Teacher/Minority Recruitment

Superintendent Wyrosdick shared that a group will be coming together to focus on teacher recruitment in Santa Rosa School District; specifically minority teacher recruitment. He passed to Board members information that had been compiled and given to him by the Men of Vision at a recent meeting that he and Mr. Winkles had with these local community leaders and he also expressed appreciation to the Men of Vision.

3. Test Results

The Superintendent shared that we have just received FSA results - we are in the very top section of the state. Assistant Superintendent for Curriculum and Instruction Bill Emerson recognized the elementary area, including Pam Smith and April Martin, for this achievement since this was new to that grade level. Santa Rosa School District is ranked second in the state.
