EARLY CHILDHOOD DEVELOPMENT AND HEALTH SERVICES

Education

- Family Night was a huge success! Families were invited to enjoy a pizza dinner and participate in Literacy Training with Jonathan Dills, Lakeshore Regional Manager. The children participated in special activities that were focused on the life cycle of a butterfly. The parents and children had a wonderful time!
- The Readiness Leadership Team met to discuss the second observational period data. Outcomes reports indicated that students had made significant progress in the five essential domains.

Health and Nutrition

- The Santa Rosa County Extension Office continued **Nutrition Lessons** for our 2, 3, and 4 year old Head Start and Early Head Start students. The 3 and 4 year old HS students have just completed a "Fruit and Veggie Challenge" with a goal of tracking and increasing consumption of these important food groups.
- A "CANNING" Workshop for our parents was conducted by The Florida Extension Office on Friday, February 26th. Participants received free materials, recipes, instruction on canning, how to safely preserve foods, and a jar of homemade Sweet Strawberry Jam.
- NATIONAL SCHOOL BREAKFAST WEEK was celebrated during the week of March 7th to March 11th. We had many fun educational activities throughout the week. Over 100 parents joined us for breakfast on Wednesday, March 9th. The Santa Rosa Extension Office provided healthy "Smoothies" for everyone and the Santa Rosa County Health Department personnel were dressed in fruit and vegetable costumes! It was a fun day for everyone that participated!

- **PURPLE UP DAY:** April is the... **Month of the Military Child!!** The month of April offers us a special opportunity to acknowledge and honor the service of our littlest heroes, our military children. Dental

- Daily Dental Hygiene continues to be promoted both in the classroom and in conjunction with meals.

We completed all Head Start and Early Head Start class dental trips and Dental Treatment Plan letters have now been mailed out to all parents/guardians along with the Form 5 from the Florida Department of Health Dental Clinic. We continue to track all students needing any further dental treatment and contacting and sending out reminders to those specific parents.

Vision, Hearing, and Growth Assessment Screenings

• Vision, Hearing, and Growth Assessment Screenings are on-going for any new students. Re-Test, Referrals, and Follow-Up continue for those students requiring further evaluation. Letters have also been sent home to parents regarding expired or expiring health requirements such as physicals, immunizations, and the lead/hemoglobin tests. Child Plus continues to be updated daily with new student information, updated physicals and/or shot records, dental information, etc...

PROGRAM DESIGN AND MANAGEMENT (PDM)

- A letter was received as formal notice that from 1/19/2016 to 1/21/2016, Santa Rosa County School District successfully passed the Head Start Key Indicators-Compliant (HSKI-C) Review Event and thus qualified for differential monitoring based on the result of the monitoring review.
- Two additional reviews will be done: Environment Health and Safety and CLASS (Classroom Assessment Scoring System) for Head Start grantees or Comprehensive Services/School Readiness for EHS grantees during the remaining course of the 5-year grant monitoring process.
- The Policy Council also met in February to discuss a need to make some changes to the Policy Council Bylaws. These changes/revisions will be submitted to the Board for approval at a later date.

Fiscal

- The Head Start program received the Financial Assistance Award on Monday, February 29, 2016 for grant period March 2016-February 2017.
- Seven schools in Santa Rosa County receive Head Start funding for Pre-K to provide a quality program to serve children and families. The program plans to apply for a COLA Grant when funding is available.
