### 2016-2017 COOPERATIVE AGREEMENT BETWEEN

# THE MILTON CHILD CARE CENTER, OPERATED BY CAPSTONE ADAPTIVE LEARNING & THERAPY CENTERS, INC.

# AND THE SANTA ROSA COUNTY SCHOOL BOARD

The Milton Child Care Center operated by Capstone Adaptive Learning & Therapy Centers, Inc. and the Santa Rosa School Board enter into this agreement to allow teen parents who attend Milton High School or other Santa Rosa County District schools and are enrolled in the Teenage Parent Program to receive child care at The Milton Child Care Center which is located on the Milton High campus in the full service school facility at 6656 Park Avenue.

#### The Milton Child Care Center agrees to provide the following services:

• Child care for a maximum of eight (8) hours per day for the following rates for days enrolled:

Infants	(0-12 months)	\$33.00 per day	\$165.00 per week
Toddlers	(13-23 months)	\$28.00 per day	\$140.00 per week
Two-year olds	(24-35 months)	\$27.00 per day	\$135.00 per week
Pre-School	(3-5 years)	\$24.00 per day	\$120.00 per week

- Quality care that is developmentally appropriate.
- Meals and snacks that are nutritional and meet the USDA Child and Adult Care Food Program Guidelines.
- Weekly attendance record of the TAPP child.
- Bill the Santa Rosa School Board within the first five (5) working days of the month for the previous month's services.
- The Milton Child Care Center operated by Capstone Adaptive Learning & Therapy Centers, Inc. agrees to hold harmless and indemnify and defend the School Board, its officer, agents, servants, and employees in their official and individual capacity against any demand, claim, suit, loss, expense or other damage which may be asserted against the School Board, its officer, agents, servants or employees in their official or individual capacity, by reason of any damage to property or injury or death of any person to a limit of \$1,000,000 which arises out of, or is incident to, any act of omission of the Milton Child Care Center operated by Capstone Adaptive Learning & Therapy Centers, Inc. or its employees in the performance or attempted performance of said agreement.
- The Milton Child Care Center must employ and agree to provide the Santa Rosa School Board a copy of the following certification(s) for individual(s) supervising children enrolled for child care through the Santa Rosa School District:
  - Teaching Certificate with one of the following certifications:
    - Early Childhood Education
    - Prekindergarten Education
    - Preschool Education

Primary Education

Or

• CDA (Childhood Development Associate) certification or CDA equivalent.

## The Santa Rosa School Board agrees to:

- Refer any Milton High School teen parent to the Milton Child Care Center for the enrollment process of the child.
- Pay the invoiced amount within fifteen (15) days of receipt of the invoice for the previous month.
- The Board will reimburse the Agency for up to eight (8) days of absence per month per child.

The signatures below make this a binding agreement between the Milton Child Care Center and the Santa Rosa School Board. The agreement may be amended or terminated at the request of either party after thirty (30) days' written notice.
