#### EARLY CHILDHOOD DEVELOPMENT AND HEALTH SERVICES

#### Education

- Preschool students participated in graduation and end-of-year activities to celebrate completing Head Start and Voluntary
  Pre-Kindergarten. Families were given a *Getting Ready for Kindergarten* book that provides resources and activities
  that will assist them helping their children continue their learning throughout the summer.
- The Readiness Leadership Team (RLT) met to discuss data from the 2015-16 school year's final assessment period. Legislative mandates required that all programs teaching Voluntary Pre-Kindergarten would use Teaching Strategies Gold (TSG) as their ongoing assessment during the 2015-16 school year. However due to non-funding of TSG for the 2016-17 school year, the Santa Rosa County District Schools Head Start and Early Head Start Programs will no longer use TSG and instead return to using Galileo for the upcoming school year. Galileo offers an assessment that provides the program with the information that is needed to document and report student progress. As part of the assessment change, the readiness goals will be revised and aligned with Galileo.

## **Health and Nutrition**

• The Santa Rosa County Extension Office completed this school years Nutrition Lessons for our 2, 3, and 4 year old Head Start and Early Head Start students. Our teachers completed an end of the year evaluation on our Nutrition Program and our partnership with the Florida Extension Office. The results of the survey were extremely positive. We are presently in the process of planning and scheduling Nutrition classes and workshops for our students, parents, and staff for this next school year.
