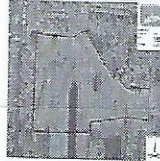

NOTICE OF PROPOSED PURCHASE OF  
REAL PROPERTY UNDER OPTION CONTRACT  
NOTICE IS HEREBY GIVEN that The School Board of Santa Rosa County, Florida  
proposes to purchase certain real property for public educational facilities, auxil-  
iary facilities, and related institutional uses and purposes under an "option con-  
tract" as defined in Section 1013.14, Florida Statutes. The property is located  
within the City of Gulf Breeze, Santa Rosa County, on the south side of Santa Ro-  
sa Drive near the intersection with College Parkway, and is approximately 45  
acres in size. An area map depicting the property is shown below.



A meeting will be held on Tuesday, March 10, 2020, at 9:00 am, or as soon  
thereafter as the matter may be heard, in the School Board Meeting Room, 5086  
Canal Street, Milton, Florida, at which time the School Board will consider  
whether to approve an agreement to purchase the described property.

Any person who decides to appeal a decision made by the School Board regard-  
ing any matter considered at this meeting or hearing will need a record of the  
proceeding. For this purpose, an individual may need to ensure that a verbatim  
record of the proceeding is made, at the individual's own expense, which record  
includes the testimony and evidence upon which the appeal is to be based. See  
Section 286.0105, Florida Statutes. If due to a disability, you need special accom-

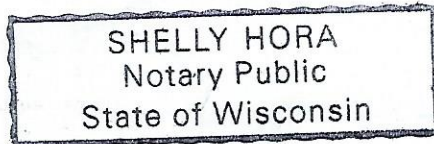
