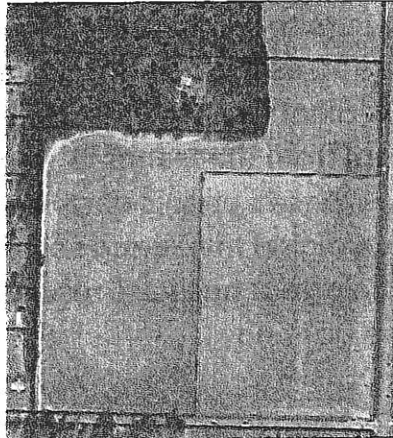

**NOTICE OF PROPOSED PURCHASE OF REAL
PROPERTY UNDER OPTION CONTRACT**

NOTICE IS HEREBY GIVEN that The School Board of Santa Rosa County, Florida, proposes to purchase certain real property for public educational facilities, auxiliary facilities, and related institutional uses and purposes under an "option contract" as defined in Section 1013.14, Florida Statutes. The property is located within the Pace community, Santa Rosa County, at the northwest corner of Wallace Lake Road and Chumuckla Highway (County Road 197), and is approximately 35 acres in size. An area map depicting the property is shown below.



A meeting will be held on **September 24, 2020, at 6:30 p.m.**, or as soon thereafter as the matter may be heard, in the cafeteria at **Woodlawn Beach Middle School, 1500 Woodlawn Way, Gulf Breeze, Florida 32561**, at which time the School Board will consider whether to approve an agreement to purchase the described property.

Any person who decides to appeal a decision made by the School Board regarding any matter considered at this meeting or hearing will need a record of the proceeding. For this purpose, an individual may need to ensure that a verbatim record of the proceeding is made, at the individual's own expense, which record includes the testimony and evidence upon which the appeal is to be based.
