I am writing to request that the Navarre HS Chorus can again perform at Saint Sylvester Catholic Church for the 2020-2021 School year.


Due to COVID, I have not scheduled any concerts for the entire first semester. However, I would like to use Saint Sylvester as a venue in October to make a CD of my students singing. I have already spoken with Saint Sylvester and they are very excited about this opportunity. My plan is to have each class come into the church to record 1-2 songs. While in the church, we would be able to properly social distance them. We would also require all students to wear a special mask made specifically for singing. They would wear this at all times.
