PROGRAM DESIGN AND MANAGEMENT (PDM)

The Policy/School Advisory Council met on November 6 and December 11. The council engaged in School Readiness training, Parent, Family and Community Engagement training, and received reports from each Service Area Specialist. In November, the council approved funding for the New Continuation Grant FY 2021-2022, Training & Technical Assistant Plan, and the Transportation Waiver Request.

On December 16, the Program received a letter from the Office of Head Start regarding the Focus Area 1 monitoring review of Santa Rosa County School District's Head Start Program. The Review will be conducted the week of February 1, 2021.

- The approved annual funding amount for the Continuation Grant 2021-2022 budget period from 03/01/2021 02/28/2022 is for the enrollment of 220 Head Start (HS) students and 40 Early Head Start (EHS) students for the total amount of \$2,824,705.00. PARENT, FAMILY AND COMMUNITY ENGAGEMENT (PFCE) / MENTAL HEALTH

Community Partners Providing Food Security to Families

Food Raising Friends (FRF) helped us to provide supplementary food to 47 families (200 people) during the Thanksgiving break, 54 families during the Christmas break, and 6 families (205 peoples) during other times during those months. In total FRF provided our families 162 food bags to supplement resources to families facing food insecurity at this time.

In addition, Woodbine Community Church is Pace, provided 37 families with food boxes for Thanksgiving.

Resourcing Families with Clothing

During the month of November, the Department of Transportation in Milton held a clothing drive to provide our teachers and clinic with clothing for children that have accidents at school and do not have a change of clothes. As a result of this drive, the DOT has decided to collect clothing year round to provide for families that are in need in our program.

In addition, we provided backpacks to children that did not have one and referred families to community resources for assistance with utilities, finding work, and securing health and dental coverage for their family.

During the months of November and December we provided 15 pairs of shoes and 15 jackets to the children in our program. As we enter the winter months, we anticipate a heightened need to serve our families with clothing.

Family Services Parent Conferences and Goal Planning

An important part of the Head Start Program is the Partnership Agreement. Through this agreement, families agree to meet certain expectation within the program. One of these is to meet with their assigned family advocate and complete a survey that helps us identify family strengths and needs. This survey assists us in knowing ways to connect families with community resources that can help meet their needs. In addition, we encourage families to write a family goal in an area of their family life that they would like to see change (i.e. housing, education, employment, etc.). This year, as of November 100% of our families participated in these conferences and most of them wrote goals. Currently family advocates are following up with families to assess their progress.
