MEETING MINUTES SCHOOL BOARD OF SANTA ROSA COUNTY September 9, 2021-6:30 PM

A. Call to Order and Roll Call

The School Board of Santa Rosa County met in regular session at 6:30 P.M. with the following members present: Mrs. Wei Ueberschaer, Chairperson; Mrs. Linda Sanborn, Vice-Chairperson; Mr. Charles Elliott, and Mrs. Elizabeth Hewey. Mrs. Carol Boston was not present as she was out of town.

Also present were School Board Attorney, Terry Harmon; and Dr. Karen Barber, Superintendent of Schools and Secretary.

B. Pledge of Allegiance

Chairperson Mrs. Wei Ueberschaer called the meeting to order and Mr. Clark Youngblood, Curriculum Coordinator for Social Studies, led us in the Pledge of Allegiance to the Flag and in a moment of silence.

C. Approval of Minutes

1. Approval of School Board Meeting Minutes of August 19, 2021

Motion to Approve was moved by Charles Elliott, Seconded by Elizabeth Hewey. Motion Passed by a Vote of 4 - 0.

D. Oral Written Communications

Dr. Barber invited Clark Youngblood to come forward and share information about American Founders Month which is September, and Constitution Week, September 17-23.

Mr. Youngblood talked about some of the great things happening in social studies in our district. We have teachers who are truly teaching their content; working to educate our future to understand our civil liberties.

He also spoke of how important Patriots Day is and the meaning of September 11. Mr. Youngblood has been sending out instructional packets based on grade level; we need to start that knowledge base of why September 11 is so important. We want students to recognize the difference between the Declaration of Independence and the Constitution - two of the greatest documents in our history; over 3800 copies of the

Constitution have been given out. He shared that he's had students come back to him 25 years later and pull out their pocket Constitution; this is meaningful.

September 20-24 is Celebrate Freedom Week which includes activities centered around the Declaration and Constitution, the Pledge of Allegiance, with the goal of planting that seed early.

Dr. Barber expressed appreciation to Mr. Youngblood for his leadership in teaching history. SRCSD ranked fourth out of 67 counties in history; and fifth in civics.

Dr. Barber reviewed Covid 19 information on our website. Masks continue to be highly recommended. We have many documents on our website including student rates listed by school and employee rates listed by work site. She added the numbers are declining.

Jeff Baugus came to the podium to show online resources that students may use including tutorials on how to log in Focus and how to access Classlink. This will help students who are not in the classroom stay connected to curriculum and not fall behind.

F. Public Hearing

1. Conduct Second Public Hearing on the Proposed/Tentative 2021-2022 Budget

Chairperson Wei Ueberschaer asked if anyone would like to address the Board regarding the proposed/tentative budget for 2021-2022. No one came forward.

Susan McCole, Assistant Superintendent for Finance, came forward to provide a brief review of the district summary final budget including the annual financial report for fiscal year ending June 30, 2020.

• The estimated end of year fund balance (fund 100) is \$13,658,743.21. This is a decrease from the final budget at the end of the year. The majority is due to cuts received from the state and additional expenses the state imposed.

- Increased FTE may result in increased funding.
- Total available budget for all parts, \$35,192,855.78
- Another slide showed projected FCR for the end of June 2022 to be 6.12%.
- Debt service went up \$428,931 due to COPS revenue entries.

Motion to Approve was moved by Linda Sanborn, Seconded by Charles Elliott. Motion Passed by a Vote of 4 - 0.

The Board approved recommended Required Local Effort Millage at a total of 3.6560 Mills and raising \$48,173,990.

Motion to Approve was moved by Elizabeth Hewey, Seconded by Linda Sanborn. Motion Passed by a Vote of 4 - 0.

The Board approved recommended Discretionary Millage at .7480 Mills raising \$9,856,167.00.

Motion to Approve was moved by Charles Elliott, Seconded by Linda Sanborn. Motion Passed by a Vote of 4 - 0.

The Board approved the recommended Capital Outlay Millage at 1.5000 Mills raising \$19,765,040.00 for a total Millage of 5.904 Mills.

Motion to Approve was moved by Elizabeth Hewey, Seconded by Linda Sanborn. Motion Passed by a Vote of 4 - 0.

The Board approved a total Operating Budget of \$257,942,051.41 and a total budget of all budget parts of \$432,751,554.00.

Motion to Approve was moved by Charles Elliott, Seconded by Elizabeth Hewey. Motion Passed by a Vote of 4 - 0.

The Board approved Resolution Number 10-04 adopting the final budget for fiscal year 2021-2022.

2. Financial Statement

Motion to Approve was moved by Elizabeth Hewey, Seconded by Linda Sanborn. Motion Passed by a Vote of 4 - 0.

The Board approved the Financial Statement as recommended.

G. Public Forum- (Request to address the School Board regarding an item not on the agenda)

Chairperson Wei Ueberschaer asked if anyone would like to address the Board. The following citizens came forward.

Sharon White came forward to express her concern with an assignment

her freshman son at Gulf Breeze High was given. Mrs. White read some of the words she stated are from the assignment and textbook. She then asked if the content is appropriate for a high school student.

Larry Hetu stated that Governor Desantis is fighting to keep our kids mask free. He feels that it's great that it's optional but thinks it's a disgrace that the School Board and Superintendent are wearing masks.

Len Cross feels that individual rights are being violated because of the pandemic. He stated that contact tracing is divisive.

John Clinton came to the podium and expressed appreciation for being added to the Covid guideline committee. Mr. Clinton likes the trend data that is being posted on the website. He continued that we could do a better job with transparency - the number of quarantined students who test positive. Mr. Clinton does not agree with the vaccine mandate that President Biden announced and hopes the School Board will fight it.

Kari Hill provided the Board with a substitute pay comparison with our neighboring districts, Escambia and Okaloosa. She requested the Board review and consider making changes to the pay and hiring fees for substitute teachers to increase recruitment and retention of quality substitute teachers in our county.

Mrs. Ueberschaer asked if anyone else would like to address the Board. There was no response and the Public Forum was closed.

Executive Session

School Board Attorney Terry Harmon explained the process for a shade/closed session for the Board to meet with private counsel to discuss litigation with a certified court reporter present. No action will be taken during the shade meeting.

Motion to recess for a shade meeting was moved by Board Chairperson Wei Ueberschaer; Seconded by Charles Elliott. Motion passed by a vote of 4-0.

The regular meeting reconvened at approximately 7:56 P.M.
