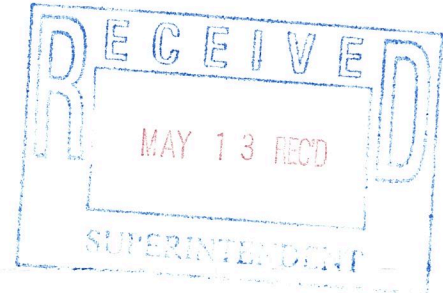

The Florida School Labor Relations Service (FSLRS) and Florida Educational Negotiators (FEN) dues are combined and have neither changed nor increased since 2005. Our primary purpose is to share information, ideas, and solutions to problems which members encounter every day in the field of labor relations and employment. FSLRS and FEN served sixty-four districts last year and is striving to have a meaningful presence in all sixty-seven.

Our services include conducting member requested surveys, researching issues for individual member districts and providing workshops and trainings.
