EDUCATIONAL MEDIA MATERIALS SELECTION 4.22*+

- I. <u>Objectives of Selection The primary objective of the school's educational media</u> center is to implement, enrich, and support the educational program of the school. <u>The center shall provide a wide range of materials on all levels of difficulty, with</u> diversity of appeal, and the representation of different points of view. The School Board asserts that the responsibility of the media center is to provide:
 - A. <u>Instructional and supplemental materials that will enrich and support the curriculum, taking into consideration the varied interest, abilities, age, and maturity levels of the students being served.</u>
 - B. <u>Materials that will stimulate growth in factual knowledge, literary</u> <u>appreciation, aesthetic values, and ethical standards.</u>
 - C. <u>A background of information enabling students to make intelligent</u> judgments in their daily life.
 - D. <u>Materials on opposing sides of controversial issues in order that students</u> <u>may develop, under guidance, the practice of critical analysis of all media.</u>
 - E. <u>Materials representative of the many religious, ethnic, and cultural groups</u> and their contributions to the heritage and culture of America and the world.
 - F. <u>A comprehensive collection appropriate for the users of the media center</u> placing principle above personal opinion and reason above prejudice in the selection of materials of the highest guality.
- II. Legal Responsibility for Selection. The School Board is legally responsible for all matters relating to the operation of the Santa Rosa County District Schools. The responsibility for the selection of educational materials, regardless of whether the book is purchased, donated, or otherwise made available to students is delegated to a school district employee who holds a valid educational media specialist certificate. School principals are responsible for overseeing compliance with school district procedures for selecting school library media center materials.
- III. <u>Parental Responsibility. Parents shall have the right to review materials in the</u> <u>media center and request that it be noted in the student's library record that the</u> <u>student not be allowed to check out certain material.</u>
- IV. <u>Criteria for Selection of Media Materials</u>
 - A. <u>The standards to determine the propriety of the educational materials shall</u> <u>be pursuant to Florida Statutes.</u>

- B. <u>First consideration shall be given to the needs of the individual school based</u> on knowledge of the curriculum, of the existing collection, and of the needs of children and youth. Requests from users of the collection, (*i.e.*, administrators, faculty, parents, and students) shall be given high priority.
- C. <u>Materials shall be considered on the basis of accuracy of content, overall</u> <u>purpose, timeliness, importance of the subject matter, quality of the</u> <u>writing/production, readability and popular appeal, authoritativeness,</u> <u>comprehensiveness of material, reputation of the publisher/producer,</u> <u>reputation and significance of the author/artist/composer/producer, format,</u> <u>and price.</u>
- D. <u>In determining the suitability and value of the material included in the</u> <u>collection, consideration of the following elements must be given:</u>
 - 1. <u>Religion. Factual, unbiased material which represents all major</u> religions
 - 2. <u>Ideologies. Factual information on any ideology or philosophy that</u> <u>exerts a strong force in society</u>
 - 3. <u>Sex Education. Factual information, appropriate for the age group or</u> related to the school curriculum
 - 4. <u>Sex. Obscene, pornographic, and harmful to minors material as</u> <u>defined in Florida Statute 847.001 or when taken as a whole, is</u> <u>without serious literary, artistic, political, or scientific value for minors.</u>
 - 5. <u>Profanity. The fact that limited profanity appears in material shall not</u> <u>automatically disqualify a selection. However, care shall be taken to</u> <u>exclude materials using profanity in a lewd or detrimental manner</u> <u>and not in context with the material</u>
 - 6. <u>Science. Factual information about medical and scientific knowledge,</u> <u>without any biased selection of facts.</u>
- E. <u>Gifts of media or money shall be accepted with the understanding that their</u> <u>use or disposition shall be determined by those persons having the</u> <u>responsibility for acquisitions, according to the same selection criteria and</u> <u>procedures as purchased materials.</u>
- V. <u>Procedures for Selection</u>

- A. <u>In selecting materials made available to students through the district library</u> media center, the school media specialist shall:
 - 1. <u>Consult with reputable, unbiased, professionally recognized</u> reviewing periodicals and school community stakeholders (including, media staff, curriculum consultants, faculty, parents, and community members).
 - 2. <u>Require that book selections meet the criteria set forth in s.</u> <u>1006.40(3)(d). F.S.</u>
 - 3. <u>Library media center collections will:</u>
 - a. <u>be based on reader interest,</u>
 - b. support state academic standards and aligned curriculum
 - c. support the academic needs of students and faculty
 - 4. <u>When considering materials to be purchased, the media specialist</u> shall follow these procedures:
 - a. <u>Purchase materials which are outstanding and frequently</u> <u>used;</u>
 - b. Periodically replace periodically worn or missing basic items;
 - c. <u>Withdraw out-of-date or unnecessary items from the collection</u> or items required to be removed pursuant to subparagraph 2; and replaced by new and age-appropriate materials,
 - d. <u>Purchase materials in many types of formats: digital, e-books,</u> <u>electronically, soft, or hard bound.</u>
 - e. <u>Examine sets of materials and materials acquired by</u> subscription and purchase only material to fill a definite need.
- B. <u>District elementary schools must publish on their school website a list of all</u> materials maintained in the school library media center or required as a part of a school or grade-level reading list.
- VI. <u>Challenged Materials. Library materials deemed by some persons to be objectionable may be considered by others to have sound educational value. Any concerned parent, Santa Rosa County resident or employee of the district may request reconsideration of school library media; however, the challenged material shall not be removed from circulation during the reconsideration process. When a complaint is made, the following procedure shall be followed:</u>

- A. <u>The library media specialist shall discuss the matter informally with the</u> <u>complainant explaining the selection procedures for library media materials.</u> <u>If the complainant accepts the explanation given by the media specialist, the</u> <u>reconsideration process concludes.</u>
- B. If the explanation fails to resolve the objection, the principal will ask the complainant initiating the challenge to file, within two weeks, a formal written objection by completing a "Request for Reconsideration of Library Media" form which must reflect that the complainant has read the material in full. Failure to do so results in the conclusion of the reconsideration process.
- C. <u>Upon receipt of the completed form "Request for Reconsideration of Library</u> <u>Media," the principal shall forward copies to the appropriate personnel on</u> <u>the school-level Review Committee (a committee of teachers, educational</u> <u>media specialists and parents of the school).</u>
- D. <u>The challenged material shall remain available for circulation during the</u> reconsideration process
- E. <u>The challenged materials shall be read and re-evaluated by the committee,</u> <u>considering the specific objections raised. The committee shall report its</u> <u>decision within fifteen (15) working days.</u>
- F. <u>The Complainant shall be informed in writing concerning the school-level</u> <u>committee's decision.</u>
- G. <u>District Review Committee. If the Complainant disagrees with the decision</u> rendered by the school-level committee, an Appeal may be filed with the Santa Rosa County District Schools.
- H. <u>The Superintendent shall appoint a District Review Committee with the</u> <u>following composition:</u>
 - 1. <u>One representative of the Public Library Board;</u>
 - 2. <u>One representative of the general public at large; and</u>
 - 3. <u>One representative of a school parent organization.</u>
 - 4. <u>One principal from the level at which the complaint originated (K-5, 6-8, or 9-12).</u>
 - 5. <u>Three school-level instructional staff members including the</u> <u>following:</u>
 - a. <u>One media specialist from the level at which the complaint</u> <u>originated;</u>
 - b. One media specialist from another level; and

- c. <u>One classroom teacher from the level at which the complaint</u> <u>originated.</u>
- 6. <u>Two district-level instructional staff members including the</u> <u>following:</u>
 - a. <u>One district-level instructional staff member from the level</u> where the material is in question; and
 - b. <u>The Supervisor of Technology and Instructional Media</u> <u>Services.</u>
- I. <u>The Review Committee, in carrying out its assigned function, shall:</u>
 - 1. <u>Read, view, or listen to the material in its entirety;</u>
 - 2. <u>Check general acceptance of the material by reading reviews and</u> <u>consulting recommended lists;</u>
 - 3. <u>Determine the extent to which the material supports the curriculum;</u>
 - 4. Complete the "Checklist for Reconsideration of Library Media," judging the material for its strength and value as a whole and not in part; and
 - 5. <u>Forward, within fifteen (15) working days, a written</u> recommendation to the Superintendent.
- J. <u>The Superintendent's designee will inform the complainant and the school's</u> <u>media specialist of the committee's decision to retain or withdraw the</u> <u>challenged material as recommended by the District Review Committee.</u>
- K. If the complainant or the media specialist is dissatisfied with the District Review Committee's decision, a written appeal may be filed with the Superintendent. Failure of the complainant to file a written appeal within 30 days of the District Review Committee's decision will result in a conclusion of the reconsideration process and the decision of the District Review Committee shall be final.
- L. <u>The Superintendent shall, within 30 days of receipt of the appeal, send the</u> complainant and the school media specialist a written decision. An appeal to the School Board of the Superintendent's decision must be filed within 10 days after the Superintendent's decision.
- M. <u>The School Board shall consider the decision of the District Review</u> <u>Committee and the Superintendent and any other appropriate</u> <u>documentation (i.e., meeting summaries, material reviews, etc.). The</u> <u>decision of the School Board regarding the appropriateness of a particular</u> <u>Library Media material item will be considered final.</u>

N. Library Media materials in question, can only be removed from circulation and/or used in the school district through the procedures of this policy.
