### <u>SPECIAL CONDITIONS – CONTRACT REQUIREMENTS</u>

The following "Special Conditions" are in addition to or may change the "General Bid Terms and Conditions" previously listed. In the event of a conflict, these "Special Conditions" will have precedence.

### SCOPE:

The purpose of this invitation to bid is to establish a three (3) year contract for the purchase of paper for offices and classrooms of white, premium grade number 4, xerographic dual purpose, cut-size, virgin bond, unwatermarked, minimum 92 brightness, 20 lb. paper, 500 sheets per ream in the sizes listed herein by the Okaloosa County School District, the Santa Rosa County School District, and other eligible users. Eligible users include political subdivisions, county, local county board of public instruction, municipal, or other local public agency or authority, and state universities. Any contract established as a result of this bid is to be used primarily to replenish site inventories for office and classroom consumable paper. Contractor is required to deliver to all locations within the School District on an as needed basis.

### **CONTRACT PERIOD:**

It is anticipated that this contract will commence on or about October 14th, 2013. This contract is to be for a three (3) year period. Either party can cancel the contract, without reason, October 14th of each contract year. Cancellation must be in writing and received 90 days prior to October 14th of each contract year. Silence from both parties will be considered as acceptance for another contract year at the same terms and conditions. The resulting contract from this bid can be cancelled by the Okaloosa County School Board at any time for any cause. This condition is not to preclude providing the lowest possible price based on current economic conditions. As per Florida State Statute, this contract will be cancelled if not funded. The normal ending date for this contract shall be October 13th, 2016.

### AWARD:

This is an all or none award. The contract shall be awarded to the lowest, responsive and responsible bidder that complies with all provisions of this solicitation.

### **INTEGRITY OF BID DOCUMENTS:**

Bidders shall use the original bid proposal forms provided by the purchasing department and enter information only in the spaces where a response is requested.
