SUBJECT: 2013-2014 Salaries of School Board Members

The methodology for the annual calculation of all constitutional officers is set forth in <u>s. 145.19</u>, <u>F.S.</u> Additional information needed for the calculation of school board member salaries is contained in <u>s. 1001.395</u>, <u>F.S.</u> Attached is a chart showing the school board member salary amounts calculated in accordance with these statutory provisions.

For the most part, year over year increases or decreases in the statutorily calculated salary for local constitutional officers are attributable to changes in each county's total population in the prior year and/or to legislatively approved changes in the salary of <u>state</u> employees. This year, many districts saw growth in total population and, for the first time in several years, the Legislature approved an increase in state employee salaries. As a result of one or both of these factors, the calculated 2013-2014 salary for all constitutional officers, including school board members, increased.

In accordance with Article II, Section 5(c) of the Florida Constitution, these statutorily calculated salary amounts go into effect automatically as a matter of state law. However, please note that s. 1001.395(2), F.S. authorizes school board members to reduce their statutorily calculated salary on a voluntary basis. In addition, please be advised that, in accordance with Attorney General Opinion 1979-87, the 2013-2014 salary amount is effective as of July 1, 2013.
