

## **CLINICAL SITE AGREEMENT**

**THIS CLINICAL SITE AGREEMENT** entered into by and between **THE DISTRICT BOARD OF TRUSTEES OF PENSACOLA STATE COLLEGE, FLORIDA**, hereinafter referred to as the "College" and **SCHOOL BOARD OF SANTA ROSA COUNTY, FLORIDA** hereinafter referred to as "Cooperating Agency."

### **WITNESSETH:**

**WHEREAS**, the College has established the Bachelor of Science in Nursing (BSN) program, and such program requires the provision of practicum courses that BSN students may obtain the clinical learning experiences set forth in the curricula of the BSN program, and

**WHEREAS**, the Cooperating Agency has clinical facilities in which the students can acquire certain of the clinical learning experiences required in the curricula of the BSN program, and

**WHEREAS**, it is to the mutual benefit of the parties hereto to cooperate in the providing of clinical learning experiences to BSN students, now therefore,

**KNOW ALL MEN BY THESE PRESENTS**, that the College and the Cooperating Agency in consideration of mutual benefits that will accrue to each from providing clinical facilities for BSN students, and for other good and valuable considerations, hereby agree and covenant each with the other as follows:

- 1) The students receiving clinical experience at Cooperating Agency will be students in the College's BSN program.
- 2) The students will be in the Cooperating Agency during an academic period in which they are enrolled in a BSN course. The students will be under the direct supervision of a specified preceptor agreed upon by the College and Cooperating Agency.
- 3) College faculty and students will be subject to the rules and regulations established by the Cooperating Agency to which they are assigned. A general orientation to the Cooperating

Agency will be provided and must be attended by all students prior to beginning the clinical experience.

- 4) Students will be responsible for their own transportation in the performance of this Agreement. There will be no exchange of monies between the Cooperating Agency, the College, the Preceptor, or the Student.
- 5) The College agrees that members of the faculty may serve as consultant and on committees of the Cooperating Agency when requested by the Cooperating Agency.
- 6) The specific areas of student assignment will be negotiated as the need for clinical learning experiences are identified by the College and agreed upon by the Cooperating Agency.
- 7) Students will have current immunization records of tetanus, diphtheria, rubella and hepatitis B.
- 8) Students will provide evidence of current negative TB test within the past twelve (12) months. These documents will remain on file with the College; however proof will be provided to the Cooperating Agency upon request.
- 9) Students will successfully pass a Level II background check, hold a current American Heart Association Basic Life Support (CPR) certificate, and have a current influenza vaccine or declination of vaccine during the months of October 1<sup>st</sup> through April 1<sup>st</sup>.
- 10) This Agreement may be executed in multiple counterparts, and signed copies may be transmitted electronically by the Parties via facsimile, Portable Document Format ("PDF"), or other mutually agreeable means. When so executed and delivered by all Parties to this Agreement, each such document will be deemed an original for all purposes, and all counterparts shall constitute one and the same instrument. Signature pages may be detached from multiple, separate counterparts and attached to a single counterpart so that all signature pages are physically attached to the same document, and all such documents

shall be deemed to be of the same legal force and effect as an original of this Agreement bearing signatures originally written by all of the signatories hereto.

11) This Agreement shall commence on the Effective Date set forth below and will terminate on **6/30/2016**, whereupon it shall be automatically renewed for four (4) successive renewal terms of one (1) year each, unless either party shall give notice of its intent not to renew in writing at least three (3) months prior to the termination of the initial term or any renewal term, which notice shall allow currently enrolled students assigned to the Cooperating Agency to complete their clinical assignment at Cooperating Agency's facility.
