The authority, definitions, and methodology for the annual calculation of the salary of all constitutional officers, including school board members, is set forth in <u>Chapter 145, F.S.</u> Additional information that is specific to the calculation of school board member salaries is contained in <u>Section 1001.395, F.S.</u> As a service to our members, we have prepared a <u>CHART</u> showing the school board member salary amounts calculated in accordance with these statutory provisions by the Legislature's Office of Economic and Demographic Research.

Pursuant to Article II, Section 5(c) of the Florida Constitution, these statutorily calculated salary amounts go into effect automatically as a matter of state law. However, please note that Section 1001.395(2), F.S., authorizes a school board member to reduce his or her salary on a voluntary basis. In addition, please be advised that, in accordance with <u>Attorney General Opinion 1979-87</u>, the 2017-2018 salary amount is effective as of July 1, 2017.
