#### **AGREEMENT**

This Agreement "(Agreement") is made and entered into as of this day of

2018, by and between Santa Rosa County, a political subdivision of the State of Florida, ("County") and Santa Rosa County School District ("School District").

### RECITALS

- GCOF of Pace 81, LLC ("GCOF") owns a parcel of real property located in Santa Rosa County, Florida, identified by Parcel ID number 12-1N-29-0000-02100-0000 and being more particularly described in Exhibit "A," attached hereto.
- 2. GCOF desires to develop its property and in so doing is agreeable to providing a portion thereof to County which is acceptable for the construction of a road ("the GCOF road").
- 3. School District owns a parcel of property adjacent to and north of the property, which parcel is identified by Parcel ID number 12-1N-29-0000-00504-0000.
- 4. School District is desirous of developing its property as a future school site.
- 5. County and School District realize that the construction of a roadway across School District's property to be connected to GCOF's road is beneficial.
- 6. County and GCOF have entered into a separate agreement regarding the conveyance of the GCOF road, which agreement provides that GCOF will construct the GCOF road when it develops its property. However, should County be desirous of or in need of the GCOF road prior to GCOF's development, County may construct the road on the dedicated portion of the property.

#### WITNESSETH

#### NOW THEREFORE, the parties do agree as follows:

- A. School District shall deed to County the westerly eighty (80) feet of its parcel for the purpose of roadway construction ("Connector Road").
- B. Should County be desirous of or in need of the GCOF road prior to the development of GCOF's property, County shall construct said road and bear the cost of construction of the road, of any required traffic signals on Highway 90, and of any drainage associated with the road.

C. Santa Rosa County will, at no expense to School District, construct a roadway sufficient to provide suitable access to a school to be constructed upon the School District property when necessary for construction of a school, or within ten (10) years of the date hereof, whichever first occurs. If the roadway is not constructed as set forth above County will reconvey the property to School District.
