RE: Afternoon bell schedule for after school care

Santa Rosa County has recently had an influx of students enter our District with intensive behavioral needs in which cannot be met in our traditional continuum of ESE self-contained settings, to include SAIL, our most restrictive environment. There are now two group homes located in the Pace area that house students with special needs whom have been removed from their permanent residence for various reasons. Because we do not currently have a setting that can serve their unique academic and intensive behavioral needs, we have developed supports that will allow them to integrate slowly into their zoned schools. All decisions were made through the IEP process to ensure appropriate services, supports, and facility accommodations were developed in a collaborative approach, to include permission from the school-based administrators. The following provisions have been made to ensure a Free Appropriate Public Education is provided for these students, in a non-traditional format:

2 Board Certified Behavior Analysts

1 Paraprofessional educator - Currently is a paraprofessional in the CBSA classroom at PHS

1 ESE Teacher

1 SRO

Monday through Thursday from 4:00 - 6:00 Special transportation will be provided

This model works similarly to a homebound/home instruction model. Students will earn 3 credits in this schedule initially, with the additional, required courses added once fully-integrated in the regular school day and setting. Students are in a secluded, well-supervised classroom away from activities and other students. An additional IEP review will be held, prior to making adjustments to services to make a determination regarding readiness to transition to a traditional day.

I am requesting approval of the afternoon schedule to accommodate these students.
