Thank you for your invitation to participate in the *Foundations for Success: Developing Effective Mathematics Educators through Cognitively Guided Instruction* project. We at Santa Rosa County Public Schools see the value of professional development activities for our teachers every day, and look forward to improving the quality of education for our students.

We agree to participate in the *Foundations for Success* project and understand that we are committing to provide the project with in-kind contributions towards the project's cost-share requirement. We understand that we have been allotted seats for 420 teachers over a five-year period from spring 2018 to spring 2023. We will assist in recruiting grade-level teams of teachers to participate, and we will allocate at least half of the available seats to teachers working in high-poverty schools. We also agree to support the randomized controlled trial evaluation design, starting with the 2019–20 school year, wherein schools will be assigned at random to the treatment and wait-list control group conditions.

We will collaborate with the evaluation team to provide student data as permitted by parental consent and the research review process by both Santa Rosa County Public Schools and Florida State University.

Further:

- Mr. Jeffery Baugus will be designated as Santa Rosa County District Schools representative on the partnership advisory board. Mr. Baugus is the coordinator of math and science for Santa Rosa County School District. He understands that his responsibilities on this board include attending quarterly conference calls and annual meetings of the partnership board.
- 2. Mr. Jeffery Baugus will be designated as the financial and administrative point-of-contact for Santa Rosa County District Schools. He will be responsible for coordinating with the *Foundations for Success* staff to schedule and organize training sessions and will coordinate the provision all in-kind contribution supporting documentation quarterly, or as requested by project staff.

Santa Rosa County District Schools commits to providing the following in-kind contributions to the project. These figures are estimates and will be replaced by specific amounts when the costs are incurred.
