SUBJECT: Request to acquire a surplus School Bus #8-96 from Santa Rosa County School District for use during Kids College

This request is to acquire a surplus bus (#8-96) from the Santa Rosa County School District for use during Pensacola State College Kids College Summer Program. The School bus will be used to transport children across campus to different buildings where Kids College classes are held. For safety, this bus will also allow us to keep children out of the elements especially when it is raining and hot outside.

Please Note: Upon approval Santa Rosa School District will need a letter from Dr. Meadows requesting the surplus bus.

Notes from site visit (Inspected by Kevin Griffin, Supervisor Transportation Services): School Bus #8-96 Santa Rosa County is a well maintained 20-year-old bus. For our intended purposes to transport kids around campus it should be fine. More cosmetic issues than mechanical were noted. Drove bus around training course at the middle school. Engine had throttle response and shifted normally. Tires all had at least 6/32nds of an inch tread depth. Brake linings were not worn to the replacement indicator on the brake shoes. Interior needs a good cleaning and a few seat covers repaired or replaced. The bus has the original paint from 1996. Pensacola State College may want to invest in a paint job in the future.
