PROGRAM DESIGN AND MANAGEMENT (PDM)

On April 12, the council voted to approve the School Based Budget, engaged in Self-Assessment Training and each service area specialist gave a monthly report.

Cindy Kaier, our Office of Head Start Region IV, Education Specialist conducted a Practice Based Coaching Training on April 2nd and 3rd. Both Escambia and Okaloosa County Head Start Programs participated in the training.

- The Head Start/Early Head Start program received the EHS Supplemental Grant to Increase Hours on 3/26/2019. This is for budget year 2019-2020.
- The Head Start/Early Head Start program received the FY 2019 Cost-of-Living Adjustment (COLA) Supplemental Grant on 3/28/2019. This is for budget year 2019-2020.
- The SAC (School Advisory Council) met, discussed, and approved the School-Based Budget/901 Account for the 2019-2020 school year on 4/12/2019.
- The Semi-Annual Non-Federal Share/In-Kind reports were submitted to the District on 4/15/19.
- The Head Start/Early Head Start Program submitted the Head Start Change of Scope-Enrollment Application in HSES for the 2019-2020 budget period on 4/16/2019.
- The 425 Federal Financial Report was submitted to the District on 4/22/19 for budget year 3/1/2018 2/28/2019

Education

- During the month of April, the Education Department hosted the Practice Based Coaching training with Cindy Kaier. The training was very beneficial for the new curriculum coach Sally Baker. There were two other Head Start programs in attendance.
- Ms. Hudson and Mrs. Baker attended the Frog Street Leadership conference in Kissimmee, Florida. The training provided in depth information about the Frog Street Infant & Toddler and Frog Street Three's curriculum.
- Santa Rosa County School District (SRCSD) Head Start and Early Head Start Programs conducted the annual self-assessment on Thursday April 18, 2019. The Self-Assessment team consisted of community partners, the local education agency, parents, and program staff.

Environmental Health and Safety

- All 7 Head Start Centers are in compliance with their School-Site Safety Reporting.
- We had a Threat Assessment Meeting on Thursday, April 11th
- Our monthly fire drill was conducted on April 25th. We used the regular fire exit route during the drill.
- On Tuesday, April23rd, the Santa Rosa Health Department in conjunction with the University of West Florida and the 5-2-1-0 campaign came to our campus and read to every class the book "Walker Finds His Wiggle." At the conclusion all students and staff were given their very own book. The focus of this program is healthy eating, less screen time, and exercise!!
- On Wednesday, April 24th, we had another CPR/AED/First Aid Re-Certification Class. We had 7 staff members get re-certified in CPR. This gives us a grand total of 60 staff members that are certified in CPR/AED/FIRST AID.
- We are continually tracking and monitoring compliance of all our student's physicals, immunizations, lead, hemoglobin, and our dental treatment plans. Letters have been mailed to the parents whose children are not in compliance in any of these areas. We also have just completed the final Growth Assessment on all our students.

Nutrition

Here is a summary of nutrition activities that we have either completed or have planned:

- The final Monthly Nutrition Lessons for our 2-year-old Early Head Start students and our 3 and 4-year-old Head Start students were completed in April. A special thanks to Instructor JoLynn Peoples and the Florida Extension Office for providing this nutrition curriculum and lessons to our Head Start Pre-K students.
- The Spring Potato Container Gardens are continuing to sprout up all over our campus. The students and staff are enjoying watching the potato plants grow. Congratulations to Mrs. Kerry in the STEAM Lab! She had the first producing potato plants and the students were excited to see our first potato!!!
- On Wednesday, April 24th, we had an Audit of our Food Service program by the USDA! The auditors were here for most of the day and gave us an excellent report after the audit! Thanks for a job well done to our Food Service Manager, Nicole Woodward and Food Service Worker, Vicki Prescott!!!

Thinking pair well with the social emotional content of the Frog Street Curriculum; Conscious Discipline.
Social Thinking provides tools for our teachers and exposes children to the concepts before they go to
kindergarten. Many of them will be in classrooms using Social Thinking, so this addition will better prepare
them for the approach to expectations when they get to kindergarten.
