Rationale for using a Religious Venue:

We, the SRC Band Directors, would like to move the Santa Rosa All-County Honor Bands Concert to Pine Terrace Baptist Church because of two reasons.

- (1). Our previous location (Milton HS Auditorium) doesn't accommodate all of the spectators and performers with adequate seating. The MHS Auditorium seats around 800-900 people...Pine Terrace Baptist Church seats 1,200 people. For the past two years, the high school honor band has had to stand along the walls while the middle school honor band performed...and vice versa. In the years prior to that, we would have 200-300 spectators standing along with the walls.
- (2). The stage lighting in the MHS Auditorium is inadequate to illuminate the honor bands while performing. There were issues with students not able to see their music during our 2019 Honor Bands Concert. New fluorescent led-light bulbs were installed this summer on the MHS stage, however the use of theatrical lighting to add color to the stage/performers is substandard (side note: we recently asked Pensacola Mainstage Theatrical Supply to provide a detailed quote to bring the theatrical lighting up to modern-day standards. The price was \$185,000.)

Having two band programs (Hobbs MS & Pace HS) who have utilized these facilities in the past...and having personally attended their concerts, we feel that this location would provide a much more comfortable environment for our spectators and add to the overall experience of the performance.
